Visas, Hotel and Health

Visa

Please note that Slovenian citizens need a visa to enter Nigeria. Your passport must be signed and valid for at least six months beyond the date of the entry into Nigeria (with available blank pages). An onward or return ticket is also required. *The visa application can easily be done on your behalf by the Slovenia-Nigeria Chamber of Commerce*
